To request a City of Houston Police Clearance Letter for immigration, international travel or adoption purposes, please follow the process outlined below:

- Complete and sign the Clearance Letter Application (phone # and/or an e-mail address must be provided).
- Include a photocopy of one of the following acceptable forms of identification: a valid state issued identification (with a current address), certified birth certificate, valid passport, valid permanent residence card or valid work authorization card. Expired identification is not valid.
- Submit a payment of \$21.30 USD per person/country (money order or personal/company check) made payable to City of Houston. Temporary checks are not accepted.
- If you have been arrested by the Houston Police Department, you must include a legible set of fingerprints (All 10 rolled fingerprint impressions). Fingerprints must come from a law enforcement agency. The finger print card must have the fingerprint technician's or officer's signature that rolled the prints, and the law enforcement agency stamp.
- Mail the required items listed above (signed application, photocopy of one accepted form of identification, payment, and set of fingerprints if applicable) to the following address:
